Background



- Northern Cape has a population of about 1.2 M with 27 Local Municipalities and 5 district municipalities.
- DENC has 5 regional offices and they are all serviced
- Waste management facilities landscape: 119 waste disposal sites, 92 Municipal and 27 Private sites.
- Compliance remains the biggest challenge
- Waste recycling is practiced but can be improved, need to move for secondary processing

Plans for the next Five years

- Alignment of all issued WML to current legislation
 - Compliance issues
 - Facilitate monitoring and Evaluation
- Roll out waste separation at source in all municipalities
 - Currently implemented at Magareng and Dikgatlong LM

- New generation By-Laws
 - Emphasis on implementation
 - Monitoring of impact
- Customizing tariff models for waste services for municipalities
