**Manual registration form for registering with the South African Waste Information System (SAWIS)  
established in terms of Section 60 of the National Environmental Management: Waste Act, 2008  
(Act No. 59 of 2008)**

### **1 INTRODUCTION**

The Minister of Environmental Affairs identified various waste activities in terms of the Waste Information Regulations (GN R625, 2012) which are required to register and report waste information to the National Department of Environmental Affairs (the Department). Persons conducting any of the activities listed in Annexure 1 of the Waste Information Regulations are required to apply to the National Department of Environmental Affairs to be registered on the South African Waste Information System within 60 days of the commencement of the regulations or an activity. The registration will be considered and the Department undertakes to communicate its decision to the applicant informing them of whether their registration was authorised or refused with reasons provided.

### **2 TO REGISTER A WASTE ACTIVITY**

In order to register your waste activity to the South African Waste Information System (SAWIS) manually, you are required to complete all sections of the form and forward the completed form to the National Department of Environmental Affairs as clearly provided for, in Annexure A of this Registration form. The National Department of Environmental Affairs will capture the information supplied on the forms, on your behalf and begin the authorization process. As with the on-line submission, upon approval of the registration, a Certificate of Registration will be forwarded to you by email or post or by any other means possible.

To continue with the registration, at least one waste activity type taking place on the site must be identified. The activity for which you are registering will be registered against a specific site or portion of land. The purpose of this is to allow you to register all of your required activities against a single site. The site and corresponding activities will therefore carry a distinguishing identification number. The site will be identified as e.g. D00018 and the associated activities as D00018-01 waste disposal, D00018-02 (waste recycler). Having registered your first activity, you will be allowed to add any new activity on the same site which requires registration.

Please note that the registration of activities for your site should be undertaken by the general manager or responsible environmental manager, referred to further as the 'Central Registry User'. This person will be solely responsible for the registration of any additional activities for the site and for the updating of all

information provided to the Central Registry. The responsible person may, during the registration process, identify persons within the company who will be responsible for providing the waste data to the SAWIS.

The responsible manager must ensure that all relevant activities have been captured on this registration form for the site before submitting the registration data for authorisation. Should the registered site have access to the internet at a later stage, additional activities may be added through logging into the Central Registry using the username and password provided during registration of the initial activities. Alternatively, information for additional activity may still be forwarded to the National Department of Environmental Affairs for capturing of additional activities on the internet.

### **3 Registration and approval process**

In order to avoid misuse of the South African Waste Information System (SAWIS), the registration and approval processes have been streamlined to allow authorization of the new registered sites by the national administrator and approval of the waste activities by the provincial administrator. This has been done to enable the relevant provincial waste information authorities to confirm the existence and location of the registered activities in their provinces. As a result the Department will be able to determine whether or not the registered sites and activities are the relevant to register and report waste information in terms of the Waste Information Regulations. It is therefore in the interests of the waste sites to provide all relevant information, as this will ensure that unnecessary time delays are avoided.

**PLEASE NOTE:** The National Department of Environmental Affairs will evaluate the information given in the registration form and may:

- 1. Authorise the site indicating that the registration for the registered facility has been authorised in terms of Regulation 6(a) of the Waste Information System Regulations.** This decision will be based on the information provided in the registration form and is dependent on whether the Provincial Waste Information Administrator (DEPARTMENT) approves the existence of the site and activities in the province in question. In the case of an approval being considered by the DEPARTMENT, the applicant must, within time frames stipulated in the Waste Information regulations, collect and report waste information to the National Department of Environmental Affairs.
- 2. Reject registration in terms of Regulation 6(b) and/ or request additional information on particular issues.** If limited additional information is required, it is in the interest of the applicant to forward this

timeously to expedite decision-making in terms of Regulation 6 (a), to ensure that the rejected registration is resubmitted within 30 days after receiving a rejection notification.

## ANNEXURE 1

### LIST OF PERSONS CONDUCTING THE FOLLOWING ACTIVITIES MUST REGISTER ON THE SAWIS IN TERMS OF REGULATION 5

#### Generators of waste

- (a) Generators of hazardous waste in excess of 20kg per day.

#### Recovery or recycling of waste

- (b) Recovery of energy from general waste in excess of three (3) tons per day.
- (c) Recovery of waste at a facility that has the capacity to process in excess of 10 tons of general waste or in excess of 500kg of hazardous waste per day, excluding recovery that takes place as an integral part of an internal manufacturing process within the same premises.
- (d) The scrapping or recovery of motor vehicles at a facility that has an operational area in excess of 500m<sup>2</sup>.
- (e) Recycling of general waste at a facility that has an operational area in excess of 500m<sup>2</sup>.
- (f) Recycling of hazardous waste in excess of 500kg per day calculated as a monthly average.

### **Treatment of waste**

- (g) Treatment of general waste using any form of treatment at a facility that has the capacity to process in excess of 10 tons of general waste or 500kg of hazardous waste per day excluding the treatment of effluent, wastewater or sewerage.
- (h) Treatment of health care risk waste regardless of size or capacity of the facility.

### **Disposal of waste**

- (i) Disposal of general waste to land covering an area in excess of 200m<sup>2</sup>.
- (j) Disposal of any quantity of hazardous waste to land.

### **Exportation of hazardous waste**

- (k) Hazardous waste exported from the Republic of South Africa.
