DC28/WML/0004/2010/AMND/2016: RENEWAL OF WASTE MANAGEMENT LICENCE FOR UMFOLOZI SUGAR MILL TEMPORARY WASTE SETTLING FACILITY

The waste management licence for the abovementioned waste management activity dated 23 June 2011 and your application for renewal of this waste management licence in terms of the provisions of section 55 of the National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008) ("Waste Act"), dated 23/03/2016 refers.

The KwaZulu-Natal Department of Economic Development, Tourism and Environmental Affairs has in terms of section 49(1) of the Waste Act decided to grant the application for renewal of your waste management licence. This Department hereby issues an addendum to your waste management Licence No: DC28/WML/0004/2010 as follow:

- This licence is valid for operation for a period of fifteen (15) years from the date of issue of this addendum.
- The licence holder must ensure that waste information is registered on the national waste information system and reported monthly as per the requirements of the regulations. http://sawic.environment.gov.za
- The licence holder must also ensure that the mixture of Ash and Filter cake disposed on site is assessed and classified every five (5) years, either according to the Waste Classification and Management Regulations 2013 or The South African Water Quality Guidelines for Irrigation purposes.
- External audits on site must be done annually and reports submitted to the department within 30 days.

The reasons for this decision are as follows:

- This Department considers the renewal non-substantive and does not expect that it will adversely affect the environment or the rights or interests of other parties.
- The department considers the requested application to be in line with compliance to the environmental legislation.
