

2. DETAILED DESCRIPTION OF WASTE GENERATING PROCESS (Attach supporting illustrations)

Recycled waste paper is pulped in order to break the paper into fibres. It goes through a series of cleaning and screening processes to remove contaminants, unusable fibre, fines, ash and ink. Water recovered during

these processes are sent to the water recovery and wastewater treatment plant. Sludge is generated during the wastewater treatment process where solids and water are separated. It is then further dewatered using screens and presses and finally it is conveyed into storage bunkers.
