NATIONAL ENVIRONMENTAL MANAGEMENT: WASTE ACT, 2008 (ACT NO. 59 OF 2008)**DECISIONS ON APPLICATIONS RECEIVED FOR THE EXCLUSION OF A WASTE STREAM OR A PORTION OF A WASTE STREAM FROM THE DEFINITION OF WASTE FOR BENEFICIAL USE**

I, Barbara Dallas Creecy, Minister of Forestry, Fisheries and the Environment, hereby under regulation 6(4) of the Regulations regarding the exclusion of a waste stream or a portion of a waste stream from the definition of waste, 2018 (the Regulations), publish decisions, made by the Deputy Director-General: Chemicals and Waste Management under delegated authority, on applications for the exclusion of certain waste streams or portions of a waste stream from the definition of waste, as indicated in the Schedule hereto.

In consideration of the applications, the criteria contemplated in regulation 7 and the risk assessment contemplated in regulation 8 of the Regulations, were taken into account.

The waste streams or portions of such waste streams excluded from the definition of waste, are subjected to risk management plans based on the risk assessments. Annual reports must be submitted to the Department in terms of regulation 10 of the Regulations.
